Changes in XC9031

The [XC9031](#) provides no changes to the RetroPie setup script. Instead we utilise a small SD card “bootloader” for the Raspberry Pi, which when inserted, will expand the file system to fill the entire space of the SD card, as well as run the RetroPie setup script, in whatever version it has contained within the SD card.

This only happens once, on initial boot, in which all future handling of RetroPie is managed after the user has installed RetroPie themselves by plugging into the Raspberry Pi.

License Information

The full GPL is presented at the bottom of this document.

Install Information

Once the SD card has been booted, (and thus, retro-pie is installed.) the user will have to format the SD card in order to put new software OS's (including their own version of RetroPie).

In a windows machine, this is as simple as plugging into the computer, right clicking to bring up the menu, and clicking “format”.

For the developers' and authors' protection, the GPL clearly explains that there is no warranty for this free software.
